

ACM20121 Certificate II in Animal Care (Release 1) – BLENDED Delivery

Student Information Sheet

ACM20121 Certificate II in Animal Care allows students to develop practical skills in animal care and gain a real understanding of animal care and welfare requirements. It is a nationally recognised qualification, and an entry point into the animal care and management industry.

Estimated duration of course

This course is delivered as a 10-week intensive course. It is important to note that if students do not reach a satisfactory level in all required assessment tasks in this timeframe, they may require additional time to attempt to achieve competency. Students will be given a maximum of two (2) weeks in addition to the (10) weeks before results are finalised. Students will also be offered access to the course materials the week before commencement to familiarise themselves with course materials before official commencement.

Expected delivery locations

Learning in this course will be through mixed delivery of Pre-recorded Video Lectures, Live Webinars and Face-to-Face Classroom sessions along with mandatory practical placement days.

All online learning will be delivered through our online learning platform Learnbook.

Face-to-face classroom sessions will be delivered at the RSPCA NSW Sydney Adoption Centre, located at 201 Rookwood Road, Yagoona, NSW, 2199.

Mandatory practical placement days will be provided at one of the following RSPCA facilities:

Behaviour and Rehabilitation Centre (Central Coast) (Lot 455 Reeves Road, Somersby, NSW, 2250) - The Shelter houses dogs undergoing rehabilitation for RSPCA NSW and has a cattery where long term cats are housed.

Illawarra Shelter (54 Industrial Road, Unanderra, NSW, 2526) - An animal shelter housing cats, dogs, and pocket pets and occasionally livestock.

Sydney Adoption Centre (201 Rookwood Road, Yagoona, NSW, 2199) - An animal shelter housing cats, dogs, and pocket pets and occasionally livestock. Students will also spend some time in the onsite Veterinary Clinic.

Hunter Shelter (6-10 Burlington Pl, Rutherford, NSW, 2320) - An animal shelter housing cats, dogs, and pocket pets and occasionally livestock. Students will also spend some time in the onsite Veterinary Clinic.

Expected delivery modes

This course is a blended delivery mode which encompasses a mixture of online learning, with face-to-face classroom sessions and practical work placement.

There is a significant online component which means students are required to have ready access to a computer or other device with web cam for live webinar sessions, and ready access to the internet. A webcam is essential for the completion of online theory assessments so that your identity can be verified. The online component also requires students to have at minimum an intermediate level of competence in computer operations and navigating the internet. The preferred browser for our learning platform Learnbook is Google Chrome.

Work placement arrangements

Students are allocated a location to undertake unpaid practical placement for the duration of the course (see 'Expected delivery locations' above). RSPCA NSW has public liability insurance for these locations. Please note that due to the nature of the work placement provided, the units chosen for this qualification and the contextualisation of other units are mainly based around companion animals and in particular dogs and cats.

Participate in 1 Live Webinar to receive results and course feedback (Approximately 30 minutes)

Language, Literacy, Numeracy and Digital Literacy Assessment requirement

As part of the application process for this course, all applicants are required to complete a Language, Literacy, Numeracy (LLN) and Digital Literacy Assessment. This will be provided to you via email correspondence after you have completed your application/registration for this course. This is a requirement under the Standards for Registered Training Organisations (RTOs) and helps us ensure you have the necessary foundational skills to successfully participate in the course. This short assessment must be completed prior to enrolment being accepted. If your results indicate that additional support or further skill development is required, our team will contact you to discuss your options. If it is determined that you are not suited to undertake the course at this time based on your LLN assessment, and you have already paid fees, you will be offered a full refund of any course fees paid.

Entry requirements

Due to RSPCA NSW policy, students must be at least 18 years old.

Students are also required to have the appropriate approval to work and/or study in Australia. If you are residing in Australia on a VISA and you are unsure of your study requirements, you can check them [here](#).

There are no education requirements for entry into this course.

Reasonable physical fitness is beneficial in order to undertake the work placement. Activities will involve animal handling and manual lifting in outdoor environments.

Due to the nature of the animal industry, emotional resilience is advantageous.

You must be immunised against tetanus prior to commencement of the course. It is the student's responsibility to ensure they are currently immunised against tetanus.

An intermediate level of computer literacy and internet navigation is essential for this course.

Students must have access to the IT equipment required to access online learning materials and complete online theory assessments. This may include:

- Laptops or Computers – (please note that our learning management system does have some capabilities to be utilised on phones or tablets, but our online theory assessments will not be able to be completed on these devices and must be completed on a laptop or computer with a web camera available). Please reach out to us before enrolling if you would like to discuss any of these requirements.
- Internet Service
- Web Camera

Students must have access to their own, or family or friends' animals that could be utilised to provide evidence for the Provide Enrichment unit within our course.

Completion of LLN and Digital Literacy Assessment (as above)

Requirements during/after the course

Students are required to access the internet for learning materials. Many public libraries provide Internet access if a student does not have their own Internet access. To find your local public library, please visit [NSW public library directory | NSW.net](#)

RSPCA NSW Sydney Site does have Wi-Fi available for students to utilise on any of the face-to-face days of the course.

Students will be provided with two student uniform shirts, which students can keep.

Students are also provided with a dog lead and treat bag which are required to be returned to the RSPCA NSW Training Team upon completion of training (or withdrawal from the course). If a student fails to return these items, they will be charged a fee for replacement.

Students are required to wear and provide their own closed-in shoes and long sturdy pants (tights are not acceptable).

Students are required to attend a minimum of 90% of the classroom sessions (both online and face-to-face), review 100% of the Pre-recorded Video Presentations and attend a minimum of 15 of the practical placement days. Any further absences will require a medical certificate or other evidence to support the student's reason for being absent and a potential extension of the course.

Successful completion of the unit involves the satisfactory completion of written and practical assessment activities. Enrolling in this course does not guarantee successful completion. Successful completion is only achieved when all assessment activities are completed to a satisfactory level.

If a student does not meet the attendance requirements above and can provide sufficient evidence in relation to their absence, they can be considered for a transfer to the next available cohort to make up any face-to-face days they may have missed.

Students will be offered 2 chances to resubmit any assessments if they have failed to reach the benchmark on the first occasion. If the student has still not reached the benchmark after the second reassessment, they may be deemed not yet competent and be required to pay a reenrolment fee to continue with further training and assessment for the course.

RSPCA NSW Training Team will refund part of a course payment when:

- A student has cancelled more than 14 days prior to the course commencement. In this case, the student will receive 75% of the remaining amount (remaining amount = fees paid minus non-refundable administration fee)
- A student has cancelled less than 14 days prior to the commencement. In this case, the student will receive 50% of the remaining amount (remaining amount = fees paid minus non-refundable administration fee)
